Under section 65 of the *Act respecting Access to documents held by public bodies and the Protection of personal information* (CQLR, c. A-2.1), the personal information that the Chief Electoral Officer is asking you to provide is confidential in nature. According, it will only be used, subject to the exceptions stipulated in the Act, for the purpose of processing the application for authorization of the political party by the persons empowered to do so.

The telephone number and email address are not mandatory, but will be used by the personnel concerned to communicate with you when needed. If you do not provide this information, the Chief electoral officer will communicate with you by regular mail and it may take longer to process the application for authorization.
